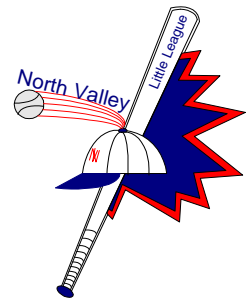

The Sponsor and the Local Little league are independent contractors with respect to one another, and neither shall have any authority to represent or bind the order in any manner or to any extent whatsoever, except as specified herein.

The Sponsor shall have the right to use the following terms in advertisements, posters, brochures, newsletter, etc.: "Sponsor of a team in the (Local Little league)." Sponsorship does NOT give the Sponsor the right to use the word "official" in connection with its Sponsorship. Any reference to the Local Little League only, and NOT for Little League Baseball. Use of the "keystone logo" or any other logo of Little League Baseball is prohibited, unless permission is expressly granted in writing by Little League Baseball International Headquarters.
